**PROPOSAL:** That the Board take the following action regarding certain current toll discount programs: (1) postpone the currently scheduled elimination of the “Green Vehicle” discount until July 1, 2011; (2) postpone the currently scheduled elimination of the “Commuter” discount until July 1, 2011; (3) postpone the currently scheduled modification of the Senior Citizen discount until July 1, 2011; and (4) permit Senior Citizen ticket holders to use those tickets indefinitely.

**PURPOSE:** To take the following action regarding certain current toll discount programs: (1) postpone the currently scheduled elimination of the “Green Vehicle” discount until July 1, 2011; (2) postpone the currently scheduled elimination of the “Commuter” discount until July 1, 2011; (3) postpone the currently scheduled modification of the Senior Citizen discount until July 1, 2011; and (4) permit Senior Citizen ticket holders to use those tickets indefinitely.

**BACKGROUND:** The Authority desires to ensure that it is acting with fiscal prudence to safeguard public funds entrusted to the Authority while being fair to its toll paying customers. DRPA has offered discount programs for Senior Citizens, Commuters and for those who use “Green Vehicles”. The Senior Citizen discount was to be modified to adjust the discount to an even 50% of the regular toll effective September 1, 2010 which would result in an increase of \$0.25 per trip for Senior Citizens. The other two programs were to be eliminated effective September 1, 2010. The Board now wishes postpone the currently scheduled elimination of the discounts until July 1, 2011.
