P R O C E E D I N G S

(9:09 a.m.)

CHAIRMAN BOYER: Please rise for a moment of
silence and then pledge to the American flag.

(Pledge of Allegiance.)

CHAIRMAN BOYER: It's pretty crowded for a
summer meeting. I would like to call to order the
meeting of the Delaware River Port Authority and ask
the Corporate Secretary to call the roll.

MR. SANTARELLI: Chairman Boyer?

CHAIRMAN BOYER: Present.

MR. SANTARELLI: Vice Chairman Nash?

VICE CHAIRMAN NASH: Here.

MR. SANTARELLI: Commissioner Fiol-Silva?

COMMISSIONER FIOI-SILVA: Present.

MR. SANTARELLI: Commissioner DiAntonio?

5 Commissioner Jones?

6 COMMISSIONER JONES: Here.

7 MR. SANTARELLI: Commissioner Martz?

8 COMMISSIONER MARTZ: Here.

9 MR. SANTARELLI: Commissioner Fentress?

10 COMMISSIONER FENTRESS: Here.

11 MR. SANTARELLI: Commissioner Imasogie?

12 COMMISSIONER IMASOGIE: You've got Osagie
13 Imasogie on the call.

14 CHAIRMAN BOYER: Thank you. Keeping with our
15 high level of transparency that has become the
16 hallmark of this Authority, we sent the agenda for the
17 meeting out publicly and now we are going to listen to
18 public comments. Are there any public comments?

19 No one from the public has any comments?

20 We'll go to the Report of the Chief Executive Officer.

21 John Hanson, have you got any comments on your
22 report?

1 MR. HANSON: I do. My report stands as
2 submitted, but I'd like to highlight a few items,
3 first and foremost our retiree presentation.

4 I'm pleased to report that we have with us
5 today Larry Yates. Larry has been with PATCO for 36
6 years and he is retiring from his position as
7 Supervisor of Stores. Larry, we appreciate your many
8 accomplishments over your career. I personally
9 appreciate the help that you gave me both in my role
10 as CFO and as CEO. We all extend our best wishes to
11 you as you begin this new chapter of your life.
12 Please come forward for a photo.

13 (Pause.)

14 MR. HANSON: We have a number of examples of
15 exemplary stewardship demonstrated by our DRPA and
16 PATCO employees. I am extremely proud of their
17 efforts. In particular, Police Sergeant Michael Voll
18 is with us today. Sergeant Voll received the 2015 Top
19 Gun Award from the New Jersey Division of Highway
20 Traffic Safety, as well as the 2015 Law Enforcement
21 Outstanding Service Award from New Jersey Mothers
22 Against Drunk Driving New Jersey at their annual

1 awards breakfast. The event recognized more than 600
2 municipal officers and state troopers who made the
3 most driving while intoxicated arrests in their
4 counties and who have dedicated their careers to
5 preventing drunk driving.

6 Sergeant Voll, who made 94 DWI arrests in
7 2015, was presented both of the ceremony's top awards.
8 They're presented annually to the officer who makes
9 the most DWI arrests in the state of New Jersey and
10 through this year. The DRPA Police Department
11 consistently ranks among the top total DWI arrests in
12 the state.

13 (Pause.)

14 MR. HANSON: When a Good Samaritan crossing
15 the Walt Whitman Bridge towards New Jersey saw a
16 kitten get tossed out of the window of a moving car,
17 she called police. As luck would have it,
18 self-professed animal lover and DRPA Police Officer
19 Richie Ridolfi was also on his way across the span.
20 They worked together to save the cat and aptly named
21 it Bridgette.

22 Next, customer Bob Costello called in to

1 convey his gratitude and appreciation for Toll
2 Collector Curtis Jackson. In early June, Mr. Costello
3 had a tire blow out on his car while going 65 miles
4 per hour and managed to make it to the bridge. He
5 found Curtis Jackson sitting outside on break.
6 Mr. Costello stated that Curtis went out of his way to
7 direct him into the parking lot and assisted him with
8 changing the tire. Mr. Costello wanted the DRPA to
9 know that we are lucky to have Mr. Curtis as an
10 employee. Mr. Costello stated that he runs his own
11 business and would be happy to have an employee like
12 Curtis Jackson.

13 Next is an update on our summer intern
14 program. DRPA and PATCO summer interns started
15 working early in June and have already made meaningful
16 contributions to our operations. I want to highlight
17 a few assignments recently completed by some of them,
18 as well as relay positive feedback on their actions.

19 Ben Franklin/Betsy Ross Bridge Toll Manager
20 Jesse Graziani shared a compliment provided to him
21 recently about summer intern Patrice Farqueson who is
22 assigned to the Ben Franklin Bridge. Jesse wrote the

1 following to Ms. Farqueson on June 22, 2016. "It is
2 our pleasure to inform you that we recently received
3 correspondence from a Ben Franklin Bridge customer
4 which was highly complimentary in the way you
5 brightened her day with your pleasant customer service
6 skills. She writes, 'Last week I pulled up to one of
7 my usual cash lanes, Toll Number 5, and I was
8 completely taken aback by the huge smile and
9 boisterous good morning that greeted me as I held out
10 my money; the warm smile and a genuine thank you was
11 also expressed by the toll booth attendant as I drove
12 off. Her smile and kindness brightened my day.'"

13 Future Engineers in Action and DRPA summer
14 interns Jane Peterken, Andrew Yoder, and Marcus
15 Lotierzo have lent their talents to review
16 specifications and Requests for Proposals, as well as
17 assisting in the organization and maintenance of the
18 Engineering Department's Project Library. They have
19 also visited several DRPA and PATCO facilities to get
20 a better understanding of our operations. Along with
21 these general engineering tasks, they have each been
22 able to play a larger role in some specific projects.

1 For example, Ms. Peterken has been working
2 with DRPA Associate Engineer Nicole Champion on
3 developing guidelines for sustainability. She has
4 been working on the new Green Procurement Process, as
5 well as developing a database of environmentally
6 friendly building products. Mr. Yoder has been
7 working with Principal Engineer Ed Montgomery to
8 develop a database of the Camden subway system for the
9 National Tunnel Inventory. Mr. Lotierzo has been
10 working with Engineering Program Manager Lennart
11 Rustam to prepare for the upcoming budget process in
12 SAP. He has been assisting in the review and
13 correction of project balances as they are converted
14 to SAP.

15 Here (holding up a brochure) is an example of
16 some of the output and reports that our interns have
17 created while working for us. That concludes my verbal
18 comments.

19 CHAIRMAN BOYER: Thank you. Any questions for
20 the CEO? There being no questions, I'll entertain a
21 motion to accept his report.

22 COMMISSIONER FRATTALI: So moved.

1 COMMISSIONER DiANTONIO: So moved.

2 CHAIRMAN BOYER: All in favor?

3 ALL: Aye.

4 CHAIRMAN BOYER: All opposed? Ayes have it.

5 Now we'll have the Report of the Chief
6 Financial Officer.

7 Jim White, do you have anything to report to
8 the Board?

9 MR. WHITE: Yes, just very briefly. Good
10 morning, Mr. Chair and Mr. Vice Chair and
11 Commissioners. My report stands as submitted. The
12 only thing I wanted to reinforce is that we
13 successfully completed two transactions on Friday,
14 July 15th, wherein we terminated Letters of Credit
15 with two banks which were maturing and replaced them
16 with variable rate LIBOR index-based loans, which are
17 direct purchase loans by several banks.

18 This replicates what we did with the BNY
19 Mellon LOC that matured in June. From the numbers as
20 of closing, I believe that the positive spread to the
21 DRPA was roughly 20 basis points on both of the
22 transactions. That translates to something in the

1 area of half a million in terms of reduction in debt
2 service on an annualized basis. So, it was very
3 successful.

4 We partnered with Bank of America and TD Bank,
5 and our friends from Wells Fargo helped us with BNY.
6 We've had three successful transactions. It's the
7 first time DRPA has done this in its history. We
8 essentially achieved several things. In addition to
9 reducing debt service, we diversified our portfolio in
10 terms of variable rate debt so that it is now 52.6
11 percent in direct purchase loans and 47.4 percent in
12 LOCs. That was one of the things we were attempting
13 to accomplish, and we were very successful in that
14 regard.

15 Other than that, the financials look very
16 good. We're still under budget. The toll revenues
17 and ridership are up. I do want to add that our
18 summer intern, Meaghan Courtney, will appear once we
19 publish it on the Annual Report as she gave assistance
20 to us prior to its submission to the GFOA. That
21 concludes my report.

22 CHAIRMAN BOYER: Thank you. Any questions for

1 Jim? No questions? We're going to go back to the
2 CEO, who omitted a part of his report.

3 MR. HANSON: An important part, too. I was
4 saving it for last -- the Baseline Assessment Security
5 Enhancement Gold Standard Award for Fiscal Year 2015.
6 TSA's Office of Security Operations, Surface
7 Transportation Security Inspection Program conducted a
8 Baseline Assessment Security Enhancement Review with
9 PATCO. It was evident from the review that PATCO
10 takes security of their system and the traveling
11 public very seriously.

12 Chris McKay from the TSA's Office of Security
13 Policy and Industry Engagement and his team are here
14 today to present the Baseline Assessment Security
15 Enhancement Gold Standard Award. They are going to
16 make a presentation and then we'll have a photo by the
17 flag.

18 MR. MCKAY: Good morning, everybody. Thank
19 you very much, CEO John Hanson, General Manager John
20 Rink, members of the Board, distinguished guests and
21 other agency presidents. My name is Christopher McKay
22 and I am the Industry Engagement Manager at TSA

1 headquarters. As such, I am responsible for
2 preventing and protecting the mass transit and
3 passenger rail industry from terrorist attacks. I
4 work very closely with our security partners and
5 industry partners around the country. I am very
6 pleased to say our partnership with DRPA and PATCO is
7 very strong.

8 On behalf of our Administrator, Peter
9 Neffenger, and Sonya Proctor, the Director of the
10 Surface Division, I would like to thank you for giving
11 me the opportunity to publicly recognize the great
12 work everyone here at PATCO and the Delaware River
13 Port Authority has been doing to secure their
14 transportation network.

15 I am extremely privileged to acknowledge the
16 hard-working and dedicated professionals here at DRPA
17 and PATCO by presenting them with the Gold Standard
18 Award in recognition of achieving security excellence
19 as evidenced by their most recent Baseline Assessment
20 Security Enhancement Review in Fiscal Year 2015. This
21 award is the highest level of recognition that we give
22 to our mass transit and passenger rail industry

1 partners around the country for their corporate
2 security enhancements.

3 In Fiscal Year 2015, there were 13 awards. I
4 am pleased to say that PATCO/DRPA was one of them.
5 The highest score you can get on the base assessments
6 is 100 percent, and I am pleased to say PATCO achieved
7 a 96 percent for this award. So let's give them a
8 round of applause.

9 For those of you who don't know, the TSA BASE
10 program is designed to establish a security standard
11 for individual mass transit and passenger rail
12 security programs across the country and to track
13 their progress. This is a voluntary program and is a
14 complete review of a transit system's security program
15 that focuses on 17 security fundamentals such as
16 security planning, emergency response training,
17 emergency response planning, security awareness
18 training, and those types of things.

19 General Manager John Rink and CEO John Hanson,
20 you should be extremely proud of the accomplishments
21 your staff has achieved. It speaks to your leadership
22 in making transit security a priority within your

1 organization, as well as to the commitment you
2 demonstrated in achieving this important goal. As all
3 good leaders know, the people who truly deserve the
4 thanks for a job well done are also those devoted to
5 the mission and who persevere on our behalf.

6 I would also like to recognize Chief Stief for
7 working with our folks at the TSA local office at the
8 airport to accomplish this significant achievement.
9 So at this time I'd like to ask CEO John Hanson,
10 General Manager John Rink, and Chief Stief to step
11 forward to accept this award.

12 I also have here with me Joseph Jacovino and
13 Gerard Spero from the TSA local office at the
14 Philadelphia International Airport. They work very
15 closely with the folks here at DRPA and PATCO to do
16 this type of work through a partnership, and I'd also
17 like to recognize them as well.

18 TSA Gold Standard Award is presented to the
19 Port Authority Transportation Corporation for
20 achieving the highest standard of excellence in
21 security under the, Baseline Assessment Security
22 Enhancement Program in Fiscal Year 2015.

1 (Pause.)

2 MR. SANTARELLI: Mr. Chairman, I would just
3 like to update the roll that Commissioner Singley just
4 joined us on the phone.

5 CHAIRMAN BOYER: Thank you.

6 Approval of June 22, 2016, DRPA Board Minutes.
7 The minutes for the June 22, 2016 Board Meeting were
8 previously provided to all Commissioners. If there
9 are no corrections, I'll accept a motion to approve
10 the minutes.

11 COMMISSIONER SWEENEY: Move the motion.

12 COMMISSIONER FRATTALI: Second.

13 CHAIRMAN BOYER: All in favor?

14 ALL: Aye.

15 CHAIRMAN BOYER: All opposed? Ayes have it.

16 Approval of the Monthly List of Previously
17 Approved Payments Covering the Month of June 2016 and
18 the Monthly List of Previously Approved Purchase
19 Orders and Contracts Covering the Month of June 2016.
20 I'll accept a motion to receive and file the List of
21 Previously Approved Payments Covering the Month of
22 June 2016, and the List of Previously Approved

1 Purchase Orders and Contracts Covering the Month of
2 June 2016.

3 COMMISSIONER FRATTALI: So moved.

4 COMMISSIONER FENTRESS: Second.

5 CHAIRMAN BOYER: All in favor?

6 ALL: Aye.

7 CHAIRMAN BOYER: All opposed? Ayes carry.

8 I would like to call for a motion to go into
9 Executive Session. The decisions made in Executive
10 Session will be made public when the issues are
11 resolved.

12 COMMISSIONER FENTRESS: Move the motion.

13 COMMISSIONER DIANTONIO: Second.

14 CHAIRMAN BOYER: All in favor?

15 ALL: Aye.

16 CHAIRMAN BOYER: All opposed? We are now in
17 Executive Session. Can we please clear the room of
18 anyone who isn't a part of the Executive Session?

19 (Off the record at 9:31 a.m.)

20 (On the record at 10:43 a.m.)

21 VICE CHAIRMAN NASH: Are there any other items
22 for Executive Session? If not, I'll call for a motion

1 to close out Executive Session and reopen the Public
2 Session.

3 COMMISSIONER MARTZ: So moved.

4 COMMISSIONER FRATTALI: Second.

5 VICE CHAIRMAN NASH: All in favor? Any
6 opposed? We are back in Open Session. Next is the
7 Approval of the Operations and Maintenance Committee
8 Minutes of July 12, 2016. The Operations &
9 Maintenance Committee Minutes of July 12, 2016 were
10 previously provided to all Commissioners. Are there
11 any corrections? Is there a motion to accept?

12 COMMISSIONER DiANTONIO: So moved.

13 COMMISSIONER FENTRESS: Second.

14 VICE CHAIRMAN NASH: All those in favor?

15 ALL: Aye.

16 VICE CHAIRMAN NASH: Opposed? The motion
17 carries.

18 Next we are going to discuss the Adoption of
19 the Resolutions approved by the Operations and
20 Maintenance Committee on July 12, 2016. They are:
21 DRPA-16-078, Capital Project Modifications; DRPA-16-
22 079, concerning Contract 17-2016 for the Betsy Ross

1 Bridge New Jersey Approach Roadway Resurfacing; DRPA-
2 16-081, which is Non-Hazardous Solid Waste Removal for
3 DRPA and Bridge Facilities; and, DRPA-16-082, which is
4 Fuel Contracts for the DRPA and PATCO. Is there a
5 motion to adopt those four resolutions?

6 COMMISSIONER FENTRESS: Move the motion.

7 COMMISSIONER DiANTONIO: Second.

8 VICE CHAIRMAN NASH: All those in favor?

9 ALL: Aye.

10 VICE CHAIRMAN NASH: Opposed? They are
11 adopted.

12 Next is the Approval of the Labor Committee
13 Meeting Minutes of July 12, 2016. The Labor Committee
14 Minutes of July 12, 2016 were previously provided to
15 all Commissioners. Are there any corrections? Is
16 there a motion to adopt?

17 COMMISSIONER FENTRESS: Move the motion.

18 COMMISSIONER DiANTONIO: Second.

19 VICE CHAIRMAN NASH: All those in favor?

20 ALL: Aye.

21 VICE CHAIRMAN NASH: Opposed? The motion
22 carries.

1 Next would be the Approval of the Finance
2 Committee Meeting Minutes of July 13, 2016. The
3 Finance Committee Minutes of July 13, 2016 were
4 previously provided to all Commissioners. Are there
5 any corrections? Is there a motion to accept those
6 minutes?

7 COMMISSIONER FENTRESS: Move the motion.

8 COMMISSIONER DiANTONIO: Second.

9 VICE CHAIRMAN NASH: All those in favor?

10 ALL: Aye.

11 VICE CHAIRMAN NASH: Opposed? The motion
12 carries.

13 Next there are three Resolutions that were
14 approved by the Finance Committee on July 13, 2016.
15 They are: DRPA-16-083, a 60-Month Lease Agreement for
16 Authority-Wide, Multi-Function Copier Devices; DRPA-
17 16-084, Camera and Call Box Maintenance Agreement;
18 and, DRPA-16-085, SAP Application Management Support
19 and Hosting Services. Are there any questions
20 regarding them? Seeing none, I'll take a motion to
21 adopt.

22 COMMISSIONER DiANTONIO: So moved.

1 COMMISSIONER FENTRESS: Second.

2 VICE CHAIRMAN NASH: All those in favor?

3 ALL: Aye.

4 VICE CHAIRMAN NASH: Opposed? Those three
5 carry.

6 Is there any Unfinished Business? Seeing
7 none, I will move to New Business.

8 There is one item of New Business for
9 consideration. It is DRPA-16-086, Consideration of
10 Pending DRPA Contracts Between \$25,000 and \$100,000.
11 Any questions? Seeing none, is there a motion to
12 adopt?

13 COMMISSIONER FENTRESS: Move the motion.

14 VICE CHAIRMAN NASH: Is there a second?

15 COMMISSIONER SWEENEY: Second.

16 VICE CHAIRMAN NASH: All those in favor?

17 ALL: Aye.

18 VICE CHAIRMAN NASH: Opposed? That carries.

19 Next is the Citizens' Advisory Committee
20 Report. Is there a report from the Citizens Advisory
21 Committee? Yes, sir, please state your name for the
22 record.

1 MR. DeSANTIS: My name is Anthony DeSantis. I
2 am a member of the DRPA CAC. We have approved one
3 more name for our CAC membership. His name is Michael
4 Devlin. His name has been submitted to the Audit
5 Committee.

6 Also, we have a member of our Personnel
7 Subcommittee who has been trying get in contact with
8 PATCO and with the PATCO union officials. He has sent
9 several requests and hasn't gotten any response yet.
10 Originally, we had some contact and we had some good
11 discussions, but there hasn't been any contact since.
12 So we would like to renew the contact with that
13 committee member. I just wanted to bring that to your
14 attention.

15 VICE CHAIRMAN NASH: John, do you want to
16 address that?

17 MR. HANSON: We're involved in union
18 negotiations right now and that is a staff function.
19 We would not involve members of an advisory board with
20 something like that. I'm not sure what you're
21 suggesting because I wasn't able to attend the last
22 Citizens' Advisory Committee meeting. But, right now,

1 while union negotiations are ongoing, we would not be
2 willing to facilitate that type of interaction.

3 We can discuss exactly what you are hoping to
4 accomplish after those contracts are done, but we
5 would not be receptive to that while the contracts are
6 being negotiated.

7 VICE CHAIRMAN NASH: Can I make a suggestion?
8 Just so that there is a clear line of communication,
9 if that member of the committee would speak directly
10 with you, Tony, to speak to John Hanson and to Mr.
11 Rink and get a sense of what the discussions involved?
12 Obviously, you're not going to involve yourself into
13 union negotiations. But if it's a matter other than
14 that, then perhaps there can be a level of
15 communication.

16 MR. DeSANTIS: Okay, I'll relay that message.
17 I have nothing else to report.

18 VICE CHAIRMAN NASH: Thank you. And please
19 thank all the members of the committee for their
20 service. They have been very, very helpful, and you
21 as well, Tony.

22 MR. DeSANTIS: Yes.
